If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Preventive care , Primary Care visit, Specialist visit, lab and x-ray, emergency care, ambulance travel, pre and post natal maternity services, allergy serum and injections, infusion therapy, chemotherapy, radiation therapy, dialysis for In- Network Providers .
